

ORDINANCE 2015-03

AN ORDINANCE APPROVING THE RECODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PART OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF HIRAM, OHIO

WHEREAS, various ordinances of a general and permanent nature have been passed which amend the Codified Ordinances of Hiram, Ohio; and

WHEREAS, numerous sections in the Traffic and General Offices Codes need to be amended or enacted so as to conform to State law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF HIRAM, Portage County Ohio, two-thirds or more of the members elected thereto concurring that:

SECTION 1: That the recodification, editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Hiram, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to wit:



Third Reading: April 14, 2015




