

ORDINANCE 2022-04

AN ORDINANCE ACCEPTING A GRANT AND AMENDING THE TEMPORARY APPROPRIATIONS IN THE GENERAL FUND (1000) POLICE (110) BY \$3,061.10 AND DECLARING AN EMERGENCY.

WHEREAS, the Police Chief for the Village of Hiram presented the Fiscal Officer with information that the Hiram Police Department has been successful in their efforts to secure a grant through the Communication Enhancement Program; and

WHEREAS, the Edward Byrne Memorial Justice Assistance Grant administered through the Ohio Office of Criminal Justice Services is a 75/25% reimbursing grant and normally needs to be funded by an advance and a transfer from the General Fund to the Communication Enhancement Program Fund (2276); and

WHEREAS, the needed Personal Body Cameras and Software have already been purchased from funds allocated within the General Fund from the 2022 Hiram Police Budget and the Police Chief would like to replenish these funds with the \$3,061.10 JAG Grant award.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Hiram, Portage County, Ohio, with at least two-thirds of the members thereto concurring that:

SECTION 1: The grant is accepted.

SECTION 2: The current temporary appropriations in the General Fund are \$404,400.00. With the addition of \$3,061.10, the new temporary appropriations will be \$407,461.10.

SECTION 3: The breakdown of the line items to be reimbursed will be as follows: In line item 1000-110-399-0000 will be \$1063.10, line item 1000-110-410-0000 will be \$998.00, and line item 1000-110-433-0011 will be reimbursed \$1,000.00. These reimbursements total \$3,061.10 from the received grant.

SECTION 4: This Ordinance is declared an emergency measure becoming effective immediately upon its passage by Council and approval by the Mayor to allow the Chief of Police to begin using the reimbursed grant funds to provide for the health and safety of the residents of Hiram.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council and any committees that resulted in such formation action were in meetings open to the public in compliances with all legal requirements including §121.22 of the Revised Code of the State of Ohio.


