

**ORDINANCE 2022-19**

**AN ORDINANCE REPEALING SECTION 351.15 OF THE VILLAGE OF HIRAM CODIFIED ORDINANCES AND ENACTING A NEW SECTION 351.15.**

**WHEREAS**, the Village Council has decided that it is appropriate to revise the fees for various parking violations in the Village of Hiram; and

**WHEREAS**, to accomplish the required changes the Hiram Village Codified Ordinances must be revised.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Hiram, Ohio, a majority or more of the members thereto concurring, that:

**SECTION 1:** The current section 351.15 of the Village of Hiram Codified Ordinances are hereby repealed.

**SECTION 2:** The provisions set forth in the attached Exhibit "A" are hereby enacted as section 351.15 of the Village of Hiram Codified Ordinances:

**SECTION 3:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of the State of Ohio.

Exhibit A

351.15 PARKING FINES AND OTHER PARKING SANCTIONS.

(a) Fines and towing sanctions for committing parking violations within the Village of Hiram are hereby established as follows.

(b) For committing a violation of Hiram Codified Ordinance Section 351.03(a)(4) Parking near a Fire Hydrant or in a Fire Lane, the following fines shall be imposed:

(1) If paid within ten days of issuance the fine shall be Forty Five Dollars (\$45.00).

(2) If paid more than ten days but before thirty days after issuance the fine shall be Ninety Dollars (\$90.00).

(3) If paid more than thirty days after issuance the fine shall be Two Hundred Dollars (\$200.00).

(c) For committing a violation of Hiram Codified Ordinance Section 351.04(f)(1) Handicapped Parking, the following fine shall be imposed:

(1) If paid within ten days of issuance the fine shall be Two Hundred Fifty Dollars (\$250.00).

(2) If paid more than ten days but before thirty days after issuance the fine shall be Three Hundred Dollars (\$300.00).

(3) If paid more than thirty days after issuance the fine shall be Five Hundred Dollars (\$500.00).

(d) For committing a violation of any other parking regulation of the Hiram Codified Ordinances the following fines shall be imposed:

(1) If paid within ten days of issuance the fine shall be Thirty Dollars (\$30.00).

(2) If paid more than ten days but thirty days after issuance the fine shall be Fifty Dollars (\$50.00).

(3) If paid more than thirty days after issuance the fine shall be One Hundred Dollars (\$100.00).

(e) The fines set forth in this section 351.15 of the Hiram Codified Ordinances are in addition to, and not in substitution for, payment of the costs imposed by the Village of Hiram or others to tow a vehicle parked in violation of the parking regulations and laws of the Village of Hiram.
