

ORDINANCE 2024-01

AN ORDINANCE AMENDING THE TEMPORARY APPROPRIATIONS IN THE OHIO AMBULANCE TRANSPORTATION PROGRAM-ARPA FUND (2153) AND DECLARING AN EMERGENCY.

WHEREAS, the Fire Chief was a successful grant recipient through the State of Ohio, Office of Budget Management's Ohio Ambulance Transportation Program and has requested the Fiscal Officer amend appropriations in a new Fund 2153 to allow the Fire Department to begin utilizing the grant funds in one of the following designated ways, Premium pay, Workforce Relief or COVID-19 Mitigation; and

WHEREAS, the Council of the Village of Hiram approved the use of these funds for Premium pay in Ordinance 2023-18 passed on September 12, 2023; and

WHEREAS, the Fiscal Officer was unable to complete the set-up process to utilize these funds in 2023 and is requesting to have these funds appropriated in 2024 in order to complete the Premium payout to fire personnel.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Hiram, Portage County, Ohio with at least two-thirds of the members thereto concurring that:


SECTION 1: The following chart outlines the authorized amendment to the enumerated fund:

SECTION 2: This Ordinance is declared an emergency measure becoming effective immediately upon its passage by Council and approval by the Mayor to allow the necessary departments of the Village of Hiram to continue to function and pay their obligations to provide for the health and safety of the residents of the Village of Hiram.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of the Ordinance were adopted in an open meeting of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including §121.22 of the Revised Code of the State of Ohio.
